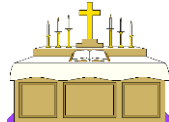

Old Business:

1. **Electronic Sign Update:** Electrical is complete. Bill Loberg is checking into what sign to order.
2. **Update on the solar panel:** Request was submitted and approved by the WCDA. Installation of the panel should happen shortly.
3. **Update on mapping out parking lot for cars:** Currently checking into ordering handicap parking signs to be closer to the door. It was determined at least a fire lane needs to be designated & handicap parking noted. This will not be addressed until next spring. Council discussed getting handicap sign parking.
4. **Update on the microphone:** Microphone has been purchased and is in use.

New Business:

1. Annual Congregational meeting at Silver Lake has been set for January 26, 2020
2. Melanie DeVries as Sunday School Superintendent will be asked to report on the checkbook balance and costs associated with the running the Sunday School at the Annual Congregational Meeting on January 26th
3. Elevator will have annual check in March. Fire Extinguishers will have annual check in January
4. Motion was made to present a grant request to the WCDA for the cost of replacing the leaking windows in the basement and seconded. Motion carried. Loberg Construction in July of 2018 gave an estimated cost of \$250 per window to put glass and cement block in 7 windows in the parish education rooms in the basement. It was decided new estimates would need to be requested to submit for the WCDA
5. It was noted the trim on the church steeple and outer windows of the church need painting. The back primary door and storm door both need to be replaced or fixed. A motion was made to request a grant from the WCDA to cover the costs of these repairs and seconded. Motion carried. Estimates will be sought to do these repairs

Next Council meeting will be at 6:30 pm – December 17th at Silver Lake

Motion to adjourn the meeting was made and seconded. Motion carried. We closed with The Lord's Prayer
