**CHURCH ATTENDANCE CONCERNS:**

- 3) **No receptions will be allowed at this time**

**Guidelines for weddings:**

- 1) **No more than 100 people in attendance (This includes Wedding Party)**
  - 2) **Pastor Randy will make sure the ushers are educated with guidelines.**
  - 3) **No receptions will be allowed**
- There was discussion on having a legal contract written up to be signed by the wedding party and/or guests not to hold the church legally responsible if anyone should contact the COVID-19 after attending the wedding.**

**All Guidelines are subject to change based on the best available medical information.**
