February 16, 2021

Old Business

1. **Steeple trim needing to be painted:** Trying to find someone to give an estimate. This cannot be addressed until next spring/summer.
2. **Basement wall under the one window which is showing a great deal of water damage:** Next Spring the basement window wells will be filled in and landscaping will be done to direct water away from the basement. Once this is completed will determine if this addresses the water issue.
3. **Stained glass window behind pastor's chair:** Grant has been submitted to the WCDDA. Will know by the end of February.
4. **Update on insurance for the church and parsonage:** We will be staying with Church Mutual as they are the least expensive for the coverage.
5. **Update on the 2021 Budget:** The 2021 proposed Silver Lake budget of \$78,348.00 was approved at the congregational meeting held on 01/24/2021.
