February 15, 2022

The council reviewed the One in Christ Report followed by Pastor Randy's report.

The Secretary's report was read and approved by all.

The Treasurer's report was given. After review, all approved, motion carried.

Old Business:

Silver Lake Fellowship: We will meet at Wedgewood Cove in Albert Lea for fellowship on March 6th.

Designation for March's noisy offering: The noisy offering will go to the Food Bank (Manna) in Worth County.

Electrician for Checking Electrical System in Church Basement: We are waiting for spring to see if there will be any leaks since doing work on the window wells last year. After that we will determine our next step.

New Business:

Garbage Removal: Jean Hrubetz contacted the Worth County redemption center in Kensett to get approval to bring any garbage from the church to their facility. Since Silver Lake is in rural Worth County they okayed this.

Lent Services in March: Silver Lake Church will host lent services on March 9th with a soup supper beginning at 6:00 p.m. Bonnie will coordinate getting soups and other supplies together. We are designating the free will offering from the meal towards the food Bank (Manna) in Worth County.

Pollards: Pollards came and sprayed for bugs on February 7th.
