Minutes Pending Approval

January 23, 2022

Pastor Randy read the Litany

Roger Larson called the meeting to order.

Secretary's report – Read and approved

Pastor Randy's report. Recruiting out to new people to join the church. Billy Graham spokesperson was 8% effective. Brochure and knocking on doors were about 2% effective and the best way to reach people is to invite your friends and family and introduce them along the way.

New Business –

Lunder budget from 2021 did not have the lawn service report due to it being added to the cemetery yearend report of \$300 dollars. The overall budget increase was \$1393.00 for Pastor Bill's wife being added to the health care insurance plan. The changes for new budget for 2022, Sandy Oudekerk motioned to approve, and Tracie Roberts seconded, motioned passed.

The landline at Lunder Church will be disconnected soon. Cell phone access is valid enough due to the lack of landline use. Tracie Roberts motioned to accept, and Guy Overland seconded, motioned passed. This changes the new proposed new budget for 2022, Sandy Oudekerk motioned to accept new budget, Tracie Roberts seconded motioned passed.

Water well, Department of Health shares that the problem with the well, is it sits in a pit that needs to be corrected. There were two bids presented: Morreim Drainage for \$7,160.00 and Lake Mills Pump Services 9,403.00 along with an estimation for a new well developed for \$17,584.00. The congregation needed to vote today to apply for grant from the WCDA. The congregation would be responsible for the 25% of either one. Sandy Oudekerk motioned to approve applying for the grant and Guy Overland seconded, motioned passed
