Minutes Pending Approval

April 19, 2022

Pastor Randy opened with devotion and prayer. The council reviewed the One in Christ Report followed by Pastor Randy's report, then said the Lord's Prayer.

Denny called the meeting to order.

The Secretary's report was read and approved by all.

The Treasurer's report was given. After review, all approved.

Old Business:

Silver Lake Fellowship: We will meet at Pizza Ranch in Albert Lea for fellowship on May 1st. Pastor Randy will call for reservations.

Designation for May's noisy offering: The noisy offering will go to the Lutheran World Relief for Ukraine.
