New business: Dennis Kreuzscher made motion to discuss making some changes to Church Mutual insurance. Premiums are increasing every year. He suggested decreasing coverage and increasing deductibles. He has been unable to get quotes on prices. Agreed to pay February payment and revisit after we are able to get quotes. Tabled for now.
